Dongfeng Motor Corporation, the parent company of the Company, recorded a total of 846,615 vehicle sales for the first five months of 2025, representing a decrease of 18.8% year-on-year. The sales volume of Dongfeng Automobile Company Limited (A-share code 600006, hereinafter referred to as "**DFAC**"), a subsidiary of the Company, recorded a sales volume of 59,859 units for the first five months of 2025, representing a decrease of 14.5% year-on-year.
